This is an agreement between the Guam Philharmonic Foundation, Incorporated (GPF); Guam Territorial Band Society (GTBS) and the Participant, _____ (and their parents if under the age of 18), who is participating with the 2024 Salzburg & Vienna Tour.

1. Off-island trips are sound educational activities that provide firsthand experiences and allow for multicultural exchanges not found in Guam. Participants under the age of eighteen who will not be accompanied by parents will be under close supervision of the chaperon(s) and by other adult Participants. Every precautionary measure will be provided for the safety of all Participants.
2. The Participant will notify the music director, trip coordinator or chaperon about any medical condition(s) the Participant has. Permission and authority to seek medical treatment for the Participant is granted to the chaperon, trip director or any other designated adult Participant, in the event there is a need while participating in this tour. Dr. Jerry Castro, MD; Lucy Joo-Castro, RN; the trip chaperon or the medical officer of the day at the nearest medical facility may act as the Participant's representative in seeking medical care. Responsibility for any added cost incurred for this treatment and transportation not covered by the insurance will rest on the Participant and must be paid within fourteen (14) days following the end of the trip.
3. The Participant will abide by the Guam Territorial Band Band Member Handbook, the Tumon Bay Youth Orchestra membership handbook, the GPF Code of Conduct and conduct him/herself in a manner positively representing the island of Guam. The Participant will not endanger the safety of the group, him/herself, and the reputation of the Guam Territorial Band, the Tumon Bay Youth Orchestra and the island of Guam. The Participant is aware that if he/she violates the conditions of this agreement, the Participant will be subjected to disciplinary action according to this agreement, and the laws of Guam.
4. The Guam delegation will adhere to the alcohol drinking age of 21 or the laws of Guam at the time of the tour.
5. Minor infractions of the rules will result in the Participant gaining additional responsibilities, such as watching equipment while other Participants are enjoying free time, or other appropriate punishment as determined by the music director, trip coordinator, or chaperon. Minor infractions include but are not limited to:
 - a. Lack of Courtesy.
 - b. Getting up late.
 - c. Failure to meet responsibilities.
 - d. Delay departure of bus.
 - e. Any infraction deemed minor as determined by each ensemble's leadership.
6. Major infractions of the rules will result in the deportation of the Participant, at the Participant's expense, and includes but is not limited to the following:
 - a. Failure to meet valid requests of the chaperon, trip coordinator or music director.

- b. Intentional tardiness.
 - c. Continued willful disobedience (especially after receiving a warning)
 - d. Unauthorized room assignment changes
 - e. Returning to the hotel after curfew
 - f. Engage in, involved directly or indirectly, any illegal activity or violating item 4 above.
 - g. Vandalizing or trashing hotels, rehearsal rooms and performance spaces.
 - h. Failure to inform the chaperon or any adult Participant of any activity that the Participant may have witnessed, or is aware of, that may endanger the safety of the individual, group, and/or reputation of Guam.
 - i. Any infraction deemed major as determined by each ensemble's leadership.
7. In the event the Participant must be returned to Guam on an earlier flight due to illness or as a disciplinary action, the Participant agrees to repay the GTBS or GPF any additional expenses because of such action within fourteen (14) days.
8. Parents/Legal guardians of Participants under the age of 18 years agree to the provisions of this agreement and will be held responsible for any action or lack thereof of the Participant.
9. The Participant, and in the case of Participants under the age of 18 years, together with their parents/legal guardians, certify that the information provided on page 1 of this agreement is true and correct to the best of his/her knowledge, and furthermore waive any and all claims against the individuals identified in item 2 above, the Summa Cum Laude Music Festival (Austria) (SCL), World Projects, Guam Territorial Band Society, Guam Philharmonic Foundation, Inc., their respective board members, employees, agents, representatives, successors, sponsors, benefactors, and other Participants, arising from or in connection with any accident, injury, illness, or other damages that may be incurred by the Participant's property in connection with the Participant's participation in this tour.
10. The Participant, and in the case of Participants under the age of 18 years, together with their parents/legal guardians, have reviewed the Guam Territorial Band Band Member Hand Book/Tumon Bay Youth Orchestra Membership Hand book and the provisions of this agreement, and therefore agree to indemnify and hold the individuals identified in item 2 above, the Summa Cum Laude Music Festival (Austria), Guam Territorial Band Society, World Projects, Guam Philharmonic Foundation, Inc.; their respective board members, employees, agents, representatives, successors, sponsors, benefactors, and other Participants harmless from and against all claims, damages, cause of action, or other liabilities that may have resulted of the Participant's action or lack thereof.
11. Participants have read and understand all the provisions mentioned in the document **SCL 2024 IMPORTANT FESTIVAL INFORMATION** posted at <https://www.guamphilharmonic.org/vienna2024-central.html>. Participants are aware that violations of the SCL Festival policies may disqualify Guam groups during the festival.
12. The Participant acknowledges that the 2024 Salzburg & Vienna Tour has been originally quoted to cost **USD \$2538.00** and all tour inclusions as outlined on the **TBYO-GTB - Vienna Ground Itinerary** posted at <https://www.guamphilharmonic.org/vienna-2024-central.html>. AIRFARE is **not** included with this price. Traveler's Insurance (Moylan's Plan F), unless declined, is included for this tour. The Participant, and in the case of Participants under the age of 18 years, together with their parents/legal guardians agree to any legitimate price changes and will pay any balance due within sixty (60) days following the completion of the trip. Complying with Guam Law, all funds raised under the auspice of the Guam Philharmonic Foundation, Inc, or Guam Territorial Band Society are organization funds. Funds raised beyond the cost of the trip may be reimbursed back to the Participant only up to the amount paid in towards this trip from personal funds. All requests for reimbursements must be made in writing within sixty (60) days of the completion of this trip to the Treasurer of the GTBS or GPF.
